# Letter from the CEO

Dear friends, partners and colleagues,

The Faith to Action Network continues to achieve exceptional results, with the staff, members and partners engaging in transformative initiatives. We had a hugely successful year in 2022, confirming our commitment to being a unique and leading global interfaith network. Our 2022 thematic focus was on, "Hearing from Faith Actors as they Promote Gender Justice." Consequently, we met with a myriad of faith actors as they worked to establish and deepen gender justice within and outside faith institutions.

Faith to Action Network continued to accompany and collaborate with faith actors in shifting harmful religion-cultural norms. We mobilized young people, women, men, senior religious leaders, and others to become champions in pursuit of gender justice. Through learning and dialogue, we promoted knowledge creation and dissemination for more effective work by faith actors. We strengthened advocacy and action while promoting effective management of the organization and coordination of the Network.

In 2022, we hosted a highly impactful conference on Women's Rights in Christianity with 88 participants from 20 countries in Eastern and Horn of Africa, Southern Africa, Anglophone Western Africa, and Francophone Western and Central Africa and the Middle East celebrating and culminating consultation meetings held between 2021 and 2022 to increase faith institution self-awareness and relevant resources that they can use to advance women and girls' human rights on a personal level as well as on an institutional (systemic) level. Participants shared experiences and envisioned a future of flourishing and harmonious communities, where everybody, regardless of religion, gender, age, culture, ethnicity, race, ability, or any other dimension of diversity can enjoy a dignified life. We continued to expand our thematic and geographical coverage in South East Asia and the Middle East, joining hands with partners who demonstrate that faith actors are significant players in the quest for gender justice. Our growth is remarkable, as we continue to attract like-minded networks, institutions, and individuals who are working for a world characterized by buoyant and healthy families, gender justice, as well as peaceful, just, and inclusive societies. The Faith to Action Network



has been intentional about giving space and voice to faith-based promoters of women's rights.

Working with our members and partners around the world, we achieved impressive results in 2022 in all our thematic areas. We secured new funding that will facilitate the work of faith actors as they engage in the quest for gender justice. We produced 15 research, demonstration, and evidence products. We contributed to 20 organizational changes and reforms within faith organizations and 19 policy changes at local, national, and international levels. We organized 641 events reaching 15,300 people. We reached 43,000 people through traditional media, including faith media and edutainment, with messages advancing Network strategic priorities. We ramped up our social media communication, enabling us to reach 4,627,872 people.

This annual report testifies to our 2022 accomplishments, as we focused on our commitment to women's rights within faith communities. For more details, please visit our website. ## WHO ARE WE?

The Faith to Action Network is a global interfaith network of 110 Baha'i, Buddhist, Christian, Confucian, Hindu, and Muslim faith organizations. Our members represent a tremendous reach across the world: faith institutions, local and national faith-affiliated organizations, and both national and international networks. They are well-placed to advance our strategic pillars, which in 2022 focused on women's rights in families, communities, nations, continents, and globally. They have demonstrated passionate commitment towards a world where the rights of women and girls are realized, with a decisive investment by faith communities.

Faith to Action Network members are diverse: hierarchical, vertical, centralized, decentralized, formal, informal, elite, grass-root movements, clergy, laity, and others. The Network values this diversity: it enables us to mobilize members based on their wide range of strengths and flexibility.

Faith to Action Network offers a non-hierarchical home for all these forms of faith-based action and sees members as the prime drivers for change. Within the Faith to Action Network, the words and actions of a senior religious leader have the same value as those of a youth leader or a woman leader from a local faith



organization. This allows Faith to Action Network to work with many different types of faith organizations and at different levels in faith hierarchies. Its focus lies not on formal representation and hierarchy, but rather on where it is possible to create change for the better. The Network brings together diverse actors who have one thing in common: a desire for progressive and positive transformation.

The Network prioritizes grassroots work to drive change, and we bridge local to national to regional to international for cross-fertilization of ideas and momentum.

### Faith to Action Network Vision

A world in which interfaith collaboration advances healthy, inclusive, just, and peaceful communities.

### Mission and Approach

The Faith to Action Network mobilizes faith actors for interfaith dialogue and collaboration to advance family health and well-being; women's rights and gender justice; and peaceful, just, and inclusive communities, consistent with one's faith.

To build an accountable movement that can achieve this mission, we accompany our members in organizational and capacity development, including resource mobilization. We amplify faith voices, conduct advocacy and communicate messages for change, including social and behavioural change. We collect and disseminate evidence, implement demonstration projects, and convene safe spaces for learning.

### Principles

The Faith to Action Network approaches its work with the following principles in mind:

Respect for human rights

1. Pluralism, inclusion, and appreciation for diversity
2. Focus on common ground, fairness and solidarity
3. Knowledge-based, oriented to innovation and learning
4. Accountability, integrity and transparency
5. Professional and solution-oriented
6. Transformative, seeking to catalyze meaningful change

# HOW WE PRODUCE RESULTS



The Faith to Action Network supports and produces research that improves knowledge and evidence in support of our thematic priorities: this included 18 research, demonstration, and evidence products in 2022. The majority of these products serve to enhance the knowledge and skills of faith communities to promote the rights of women. One very exciting and strategic development in 2022 was the progress made in generating high-quality, accessible reflections on Women's Rights in Islam. This will enable the creation of transformative material on how gender justice is at the heart of Islamic theology and practice.

We strengthen the capacity of faith actors by providing a safe space for them to learn about the faith and cultural underpinnings for their views about our thematic priorities. Our capacity-strengthening methodologies – including a faith-institution Gender Audit, Organizational Capacity Assessment tool, and Interfaith Caravan – are adapted to faith organizations' institutional cultures. Drawing on this evidence and other sources, we convene faith actors and decision-makers for mutual learning and sharing. Our learning approaches take participants out of their context, exposing them to other cultures, opinions, and approaches. This helps promote empathy for the feelings and needs of people with differing opinions and prompts internal reflection on beliefs and evidence. In 2022, we contributed to 22 organizational changes and

reforms within faith organizations, half related to sexual and reproductive health and rights (SRHR) and half to women's rights and gender justice.

Likewise, we bring faith actors to decision-making spaces to improve dialogue and understanding of faith support for Network priorities among secular duty-bearers. We believe in bringing diverse actors to the conversation table to promote women's rights. Faith organizations exert influence as strong advocates vis-à-vis authorities, impacting legal, health, and education systems. Gaining their support can have a positive snowball effect on policies in many sectors. Faith to Action Network campaigns start with context and conflict sensitivity assessments and baselines. We analyze power relationships, build inter-faith consensus, and package evidence in formats tailored to specific audiences.

We simplify scientific, medical, and legal knowledge, drawing on religious and cultural teachings and traditions and translating to local context, experience, and languages (e.g., French, Arabic, isiNdebele, Shona, Chichewa, Portuguese, and Kiswahili). For example, in 2022, we developed a simplified mentorship module on mentorship in the Luganda in the Mayuge and Lugiri districts in Uganda. This ensures that our messages reach a wider audience and inspire action at the local level and lead to more effective action to secure the rights of women and girls.

We create opportunities to engage in policy discussions at international, regional level, national and sub-national level. Our external advocacy helps faith actors raise their informed voices to influence government policies, budgets and implementation frameworks. In 2022, we contributed to 18 policy changes at different governance levels, mostly related to SRHR and health (75%) and peace and freedom of religion and belief (FORB, 25%). We mobilized 35 faith leaders and faith-inspired decision maker champions to create public pressure to defend and improve policies, mainly related to SRHR and women's rights.

As an organisation, we innovate constantly, dedicated to lifelong learning. Evaluations and scholarly reviews consistently report Faith to Action Network success in advancing sensitive topics in complex environments. While we were not reviewed in 2022, United Kingdom government (FCDO) annual reviews in 2020 and 2021 both rated the Network's SRHR program as A+, with outputs exceeding expectations. Our approaches are informed by research and evidence, and our knowledge products are designed to lead to concrete actions for

shifting away from harmful norms and practices. We lead thinking in how to advance faith communities in the path to gender justice. Academic reviews of work inspired by Faith to Action Network methodologies continue to acknowledge the creativity and impact of our knowledge products.

Our work with partners on Positive Masculinities has been recognised within the communities where it's been implemented for its dynamic impact on men and boys. The role of men as partners, theological educators, heads of faith-based institutions and government departments, etc., shows how vital it is to mobilise them to secure the rights of women and girls. Men who have attended Faith to Action Network Positive Masculinities engagements have emerged as passionate defenders of the rights of women and girls. Their testimonies underscore the strategic importance of male engagement.

## Family Health and Well-being – Advancing Sexual and Reproductive Health and Rights

Interfaith work is crucial to improving family health and SRHR. Network members invest in family health and wellbeing because it enables people to develop and enjoy full and fulfilling lives. Religion is interwoven into African and Asian life and shapes social norms and morals linked to sexuality and gender. Faith to Action Network helps faith

leaders and faith actors acquire the requisite knowledge and skills to promote social transformation and contribute to health and well-being. In 2022, we made the connection between family health and well-being on the one hand, and women's rights on the other while highlighting the connection with peaceful, just and inclusive societies.

The Network focused on improving access among very marginalized, hard-to-reach populations: poor rural women, adolescents and people with disabilities in remote, unstable, environmentally harsh regions. We work in local communities characterized by insecurity, long distances between health facilities, high illiteracy levels and occasional droughts. These are places where weak, unstable public service infrastructure and poor road network compound poverty and fragility. Such communities are also highly patriarchal with real and perceived cultural and religious barriers to family planning uptake. We have invested in promoting women's rights within such settings, seeking to shift patriarchal norms to facilitate the realisation of the rights of women and girls.

Drawing from life-giving interpretations of scripture and equipping members of faith communities to identify dimensions that help people flourish, we have trained a critical mass of committed gender activists. The Network further cultivated interest in and dedication to the rights of women and girls by promoting peer education among young people.

**“Faith Actors for Justice: Following trainings during the COVID-19 pandemic in 2021 - 2022, Faith to Action and partners led Consultations on Women's Rights in Christianity. These brought together faith actors from diverse parts of the Global South to reflect on, and initiate practical steps to, place faith communities at the forefront of promoting the rights of women and girls. This culminated in a conference hosted in Nairobi involving 74 participants from 20 countries who committed to the cause of advancing women's rights.**

**Participants found that advancing women's rights and gender justice in Christian communities starts with raising awareness among Christians about the extent of the problem; the ways in which scripture is mis-used for harmful purposes; and the lesser-known ways the Bible entreats Christians to treat all people with equally human dignity, respect and love. Women and men must work shoulder-to-shoulder to promote women's rights and gender equality in Christian communities.**

**This was a colourful and transformative event, confirming the Network's capabilities for convening for sharing and capacity enhancement.**



## The result?

Adolescent girls and young women in faith communities are being empowered through “safe spaces” where they can discuss sensitive SRHR issues without fear of judgement. They find it a lot easier to express their opinions openly with people their own age. The Network equips and empowers them with the requisite knowledge and skills to become advocates for gender justice in their families, institutions and communities.

Recognising the strategic role of faith communities in promoting social and behavioural change communication (SBCC), we mobilised faith actors to shift norms in family planning. This included using spaces of worship, expert presentations, community dialogues, radio talks and community-based information dissemination. We led innovation: establishing interfaith referral systems that collaborated effectively with healthcare providers.

Cognisant of the impact of stock outs, we helped improve systems for documentation, data management and reporting and replenishment of commodities. Where faith communities had initially been regarded as stumbling blocks in family planning, they emerged as knowledgeable and effective collaborators to health personnel. In all these undertakings, we actively upheld and promoted the rights and dignity of women. Faith to Action Network's gender work is designed to



leave no one and no place behind. We act for holistic transformation, ensuring that the needs of young, rural, and marginalized girls and women who can safely plan their pregnancies and improve their SRHR. Kenya DHS data in the communities where we worked show that we helped increased the modern Contraceptive Prevalence Rate (mCPR), reduce fertility rates and reduced unmet need, thereby helping improve maternal, new-born and child health.

To engage faith actors with decision-makers for family health and well-being, the Network conducted advocacy at diverse levels. We co-chaired the regional stakeholders' taskforce steering committee and strengthened the capacity of 55 faith leaders to present Christian and Muslim theological rationales to improve and support the sexual reproductive health bill in the East African Community (EAC).

We mobilized over 100 civil society organizations (CSOs) to continue to lobby the East Africa Legislative Assembly (EALA) on the East Africa Sexual Reproductive Health Bill 2022. To enhance the capacity of faith actors for advocacy, we developed a creative resource, Human Rights for More Than One Voice, that supports community-based advocacy for the right to health in the context of the African Union and European Union.

Faith to Action Network joined other organisations in observing the 16 Days of Activism against Gender-based Violence, 25 November to 10 December, 2022.

# Gender Justice

Believing that all people are created equal, Faith to Action Network seeks to promote positive communication of sacred texts and traditions to reflect the dignity of all human beings, including women and girls.

We encourage our members to reflect on their internal norms and practices, revisit harmful traditions and amplify life-giving norms and practices. Drawing on our moral and physical resources, we champion women's rights and gender equality in laws, policies, societal norms and people's behaviours. To advance women's rights and gender justice in 2022, the Network:

The Faith to Action Network Gender Audit methodology has emerged as a highly strategic resource. It facilitates a transformative organisational change process of embedding gender equality within faith institutions. In 2022, we facilitated interfaith conversations on women's rights and gender equality, highlighting the potential of faith communities to constitute a united front promoting the rights of women and girls.

The Network brought together participants from diverse communities of faith to interact with each other, learn from one another and combine forces to form a formidable front in upholding women's rights. In these engagements, participants find resources from within their own faith traditions, as well as complementary resources from other faith traditions, to justify the religious support for women's rights. We provide dedicated space and time enabling participants to reflect on their own experiences of gender discrimination and the role of religion in perpetuating cultural norms; to ask difficult questions related to religion and human rights; to improve religious literacy on women's rights and knowledge of key legal instruments; to support faith actors' ability to draw from the faith scriptures and teachings to promote women's rights in different parts of the world; and deepen faith actors investment in promoting women's rights.

Participants in this work have created an interfaith WhatsApp group to stir up debate and help transform social and cultural norms in the community. The interfaith members believe that working towards a more inclusive society requires collective responsibility to take actions now as enshrined in the Biblical and Quran's teachings.



## Promoting Positive Masculinities

In 2022, Network partners contributed to learning and knowledge management by developing studies and publications, including a qualitative study on harmful norms and practices and women's rights.

## Peaceful, Just and Inclusive communities

Achieving the Sustainable Development Goals (SDGs) is predicated on peaceful, just and inclusive communities. Consequently, The Faith to Action Network seeks to build peaceful, just and inclusive communities. Our work to advance peace and freedom of religion and belief (FORB) in 2022:

- achieved five public policy changes
- instigated 12 changes in faith institutions
- cultivated seven new champions
- organized 33 events reaching 1,022 people

Our work in cultivating peaceful, just and inclusive communities is undertaken with promoting gender justice in mind. Our work in the Joint Initiative for Strategic Religious Action (JISRA) puts the participation of women at the centre. This is consistent with the United Nations Security Council Resolution 1325 (2000) on Women, Peace and Security, where the well-being of women is underscored. The Network and its partners have invested heavily in ensuring that women's rights and dignity are promoted and protected.

Promoting women's rights and youth's rights has enabled us to make impressive strides in the recent past, which we attribute to focused and consistent campaigns, both locally and internationally that draw from our studies on Gender Justice and Equality from a faith perspective.



In 2022, we learned that continuous capacity strengthening is needed to shift away from harmful attitudes and mindsets. This includes “unpacking” concepts and definitions that are misquoted/ misunderstood, such as gender, equality, equity, feminism, masculinity, empowerment, decision-making and inclusion. Our partners are also discovering that women and youth are better placed to champion for their rights when they are equipped with appropriate knowledge and skills.


Harmful norms and practices remain a serious obstacle to the achievement of women's and youth rights. These include discriminatory laws, exclusion in decision-making, harmful practices such as FGM, child marriage and sexual and gender-based violence among others. Despite the many efforts of campaigns and even legal frameworks, weak enforcement mechanisms continue to undermine the fight for women's and youth's rights.

Spirited and targeted advocacy is required to challenge harmful norms and practices. Involving male champions as advocates for women's rights helps demystify attitudes and values. Collaborating with other gender movements, both state and non-state actors is critical.

To disseminate knowledge about how interfaith collaboration can advance peace-building in fragile and conflict-affected communities, the Network or its partners developed the following knowledge products in 2022:

- Western Uganda FBO Network (WUFBN) undertook a Scoping Study and Research Report to better understand the roots causes of resource-based conflicts and inform intervention strategies.
- WUFBN undertook a Scoping Study and Research Report, to better understand the harmful traditional practices that contribute to rights violations of indigenous people and inform intervention strategies
- Faith to Action Network developed a Facilitation Guide, Welcoming the Stranger, to equip local resource persons to enable conversations with faith actors to capture their contributions as faith actors with people on the move, including refugees, host communities, displaced persons, migrants.
- The Supreme Council of Kenya Muslims (SUPKEM), analysed the Kenyan legal and administrative framework to identify areas of advocacy for peace-building.

The Network lead efforts to strengthen gender equality and women's rights understanding and focus during its coordination of international advocacy on the Joint Initiative for Strategic Religious Engagement (JISRA).



We led development of an internal consensus on FORB, Women's Rights and Gender Equality and trained all JISRA advocacy participants around the world on this topic.

External evaluators have found that our peace-building work represents "an impressive and well executed initiative that promotes pluralism, respect for religious and cultural diversity and peaceful coexistence among cultures and religions." Engaging young people across faith traditions our work "succeeded in modelling practical interfaith and cultural instruments in concrete, lived contexts" and "provides valuable insights relating to the discourse on religion, pluralism, peacebuilding and human rights in Africa and globally."

We helped 12 member institutions build new interfaith initiatives in Ethiopia, Indonesia, Kenya and Uganda to advance peaceful and just societies with FORB through intrareligious, interreligious and extra-religious activities. Our intrareligious work addresses divergent doctrines and different ways of interpreting religious texts that cause tension and hostilities. Our inter-religious activities address religious discrimination through intercultural dialogue. Extra-religious work addresses FORB rights violations, discriminatory profiling by security agencies; and shrinking civic space through advocacy. Across all our peace-building work, the Network focuses on advancing pluralism, advancing women's rights and addressing marginalization of both women and youth. In Uganda alone, we prompted 160 cultural and religious leaders to participate in constructive dialogues and cooperation group engagements to promote interfaith and inter-cultural cooperation on FORB.

## Promoting Gender Justice While Building Peace

The Faith to Action Network strives to mainstream gender justice and women's leadership at all levels of its work for Peaceful, Just and Inclusive communities, positing that equal participation of men and women will strengthen local ownership and contribute to quicker reconciliation processes. A case study from the Communities Richer in Diversity project (CRID 2018-2022), found that participating in interfaith community development activities played an essential role in changing attitudes on issues such as gender equality, a stigma that is associated with any differences, and sensitivity towards other religious groups.

Evaluators of the CRID project found that while patriarchal cultural and religious values were present in nearly every context, the gender equality "starting point" varied widely across contexts. In Zanzibar, interfaith structures existed, but women were not allowed to speak in the presence of a religious leader. This required organization of sex-segregated meetings to discuss women's equality issues. Kenya partners also had to adapt their strategy, by organizing special, confidential side sessions to address women's rights.

In Egypt, gender equality is more open, inter-religious work is long-standing and women play active roles in government. As a result, progress on gender equality is highly context-specific. CRID evaluation informants presented gender equality as a series of improvements, a process toward a goal, rather than a concrete target; they characterised advancements, movement in the right direction, as achievement.

They reported having trained all people – men, women, and youth – on gender equality, with men and women equally represented and given equal space for expression. They are proud of their knowledge and skills transfer with partners on mainstreaming gender equality. They reported that organisers ensured equal participation of women and men in exchange visits, and that their participation was equally notable. They reported organising training of men on gender equality and training for women to enhance their skills and to help raise women's participation to "almost that of men."

## MANAGING FOR SUCCESS



In order to ensure a strong and vibrant faith movement for its thematic priorities, the Faith to Action Network works to continually improve the excellence and professionalism of faith community management practices; mobilize resources to get the job done; manage grants to members and partners; and ensure accountable governance.

In 2022, Faith to Action Network income remained steady at €2,585,455. We provided 14 subgrants in Kenya, Uganda, Egypt, Palestine, South Sudan, Ethiopia and Indonesia. We created 19 knowledge tools to help faith actors advance this work in 2022. To ensure subgrantees could manage the funds effectively, we assessed their capacity, developed and implemented capacity strengthening plans, installing and training them on new accounting software, putting in place systems and procedures.

The Network continued to strengthen its sustainability. Our new five-year Strategic Plan took effect in 2022.

The Trust continued to strengthen our social and organizational sustainability. We wrote new project proposals and implemented joint activities gaining new partners, including GIZ/BMZ, HealthAction International, PaRD, Interfaith Action SW Michigan, ACT Ubumbano, CCIH, Läkarmissionen, Lutheran World Federation, World Vision, and strengthened partnerships with Mensen met een Missie, ACT Church of Sweden, DSW, Network of National Human Rights Institutes, Network of Traditional and Religious Peacemakers, Options, VSO, Search for Common Ground, Tearfund, World YWCA, Brot für die Welt, ACT Alliance, WCC-EHAIA, EANNASO, UNFPA, and PS Kenya.

We were successfully audited in Kenya and Germany in 2022. An external evaluation of the four-year Communities Richer in Diversity (CRID) evaluation, implemented with the Council Anglican Provinces of Africa (CAPA) and the African Council of Religious Leaders – Religions for Peace (ACRL-RfP), found it to be “an impressive and well executed initiative.”


